I hereby convey the grant of Recognition to KAMARAJAR SCHOOL, Thalambadi Village, Namakkal Distirct, Tamil Nadu for the class LKG to VIII Standard for the period up to 24.05.2027 in compliance to Rule 12 of Right of Children to Free and Compulsory Education Act, 2009 and Rules 2011, and maintain the standards and norms as specified in section 19 of the Right of Children to Free and Compulsory Education Act, 2009.

 - (b) No child shall be subjected to physical punishment or mental harassment.
 - (c) No child is required to pass any board examination till the completion of elementary education
 - (d) Inclusion of students with disabilities/ special need as per provision of the Persons with Disabilities Act, 2016.
- The School shall follow the syllabus on the basis of curriculum laid down by 7. appropriate authority
- No unrecognized classes shall run within the premises of the school or in any 8. other place in the name of School.

- 16. Infrastructure including sanitary facilities shall be maintained as per the requirement of Tamil Nadu Combined Development and Building Rules, 2019 and related amendment, if any
- 17. The certificate of recognition issued shall be subject to the rectification of deficiencies if any as pointed out by competent authorities at any stage/time.
- 18. The management shall rectify the deficiencies pointed out in infrastructure or administration by the competent authorities
